#### SAFETY

WARNING: Improper installation, adjustment, alteration, service, or maintenance can cause injury or property damage. Refer to this manual for correct installation and operational procedures. For assistance or additional information consult a qualified installer, service agency, or the gas supplier.

WARNING: This is an unvented gas-fired heater. It uses air (oxygen) from the room in which it is installed. Provisions for adequate combustion and ventilation air must be provided. Refer to <u>Air</u> for Combustion and Ventilation section on page 6 of this manual. This appliance may be installed in an aftermarket,\* permanently located, manufactured (mobile) home, where not prohibited by local codes.

This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases.

\* Aftermarket: Completion of sale, not for purpose of resale, from the manufacturer

WARNING: This product contains and/or generates chemicals known to the State of California to cause cancer or birth defects, or other reproductive harm.

IMPORTANT: Read this owner's manual carefully and completely before trying to assemble, operate, or service this heater. Improper use of this heater can cause serious injury or death from burns, fire, explosion, electrical shock, and carbon monoxide poisoning.

## **A** DANGER: Carbon monoxide poisoning may lead to death!

**Carbon Monoxide Poisoning:** Early signs of carbon monoxide poisoning resemble the flu, with headaches, dizziness, or nausea. If you have these signs, the heater may not be working properly. **Get fresh air at once!** Have heater serviced. Some people are more affected by carbon monoxide than others. These include pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol, and those at high altitudes.

**Natural and Propane/LP Gas:** Natural and propane/LP gases are odorless. An odormaking agent is added to the gas. The odor helps you detect a gas leak. However, the odor added to the gas can fade. Gas may be present even though no odor exists.

Make certain you read and understand all warnings. Keep this manual for reference. It is your guide to safe and proper operation of this heater.

WARNING: Any change to this heater or its controls can be dangerous.

WARNING: Do not use a blower insert, heat exchanger insert, or other accessory not approved for use with this heater.

WARNING: Do not allow fans to blow directly into the fireplace. Avoid any drafts that alter burner flame patterns. Ceiling fans can create drafts that alter burner flame patterns. Altered burner patterns can cause sooting.

Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies. Do not place clothing or other flammable material on or near the appliance. Never place any objects on the heater.

Fireplace front and screen become very hot when running fireplace. Keep children and adults away from hot surfaces to avoid burns or clothing ignition. Fireplace will remain hot for a time after shutdown. Allow surfaces to cool before touching.

Carefully supervise young children when they are in the room with fireplace. When using the optional hand-held remote accessory, keep selector switch in the OFF position to prevent children from turning on burners with remote.

You must operate this fireplace with the fireplace screen and hood in place. Make sure fireplace screen and hood are in place before running heater.

Keep the appliance area clear and free from combustible materials, gasoline, and other flammable vapors and liquids.


- This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases.
- Do not place propane/LP supply tank(s) inside any structure. Locate propane/LP supply tank(s) outdoors (propane/LP units only).

#### SAFETY Continued

- 3. If you smell gas
  - shut off gas supply
  - · do not try to light any appliance
  - do not touch any electrical switch; do not use any phone in your building
  - immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions
  - if you cannot reach your gas supplier, call the fire department
- 4. This fireplace shall not be installed in a bedroom or bathroom.
- 5. Do not use this fireplace as a wood-burning fireplace. Use only the logs provided with the fireplace.
- Do not add extra logs or ornaments such as pine cones, vermiculite, or rock wool. Using these added items can cause sooting. Do not add lava rock around base. Rock and debris could fall into the control area of fireplace.
- To prevent the creation of soot, follow the instructions in <u>Cleaning and Maintenance</u>, page 22.
- Before using furniture polish, wax, carpet cleaner, or similar products, turn heater off. If heated, the vapors from these products may create a white powder residue within burner box or on adjacent walls or furniture.
- 9. This fireplace needs fresh air ventilation to run properly. This fireplace has an Oxygen

Depletion Sensing (ODS) safety shutoff system. The ODS shuts down the fireplace if enough fresh air is not available. See <u>Air for Combustion and Ventilation</u>, page 6. If fireplace keeps shutting off, see <u>Troubleshooting</u>, page 24.

- 10. Do not run fireplace
  - where flammable liquids or vapors are used or stored
  - under dusty conditions
- 11. Do not use this fireplace to cook food or burn paper or other objects.
- 12. Do not use fireplace if any part has been exposed to or under water. Immediately call a qualified service technician to inspect the fireplace and to replace any part of the control system and any gas control which has been under water.
- Do not operate fireplace if any log is broken. Do not operate fireplace if a log is chipped (dime-sized or larger).
- 14. Turn fireplace off and let cool before servicing. Only a qualified service person should service and repair fireplace.
- 15. Operating fireplace above elevations of 4,500 feet could cause pilot outage.
- To prevent performance problems in propane/LP units, do not use propane/LP fuel tanks of less than 100 lbs. capacity (propane/LP units only).
- Provide adequate clearances around air openings.

Figure 1 - Log Base Assembly




Figure 2 - Fireplace

#### LOCAL CODES

Install and use fireplace with care. Follow all local codes. In the absence of local codes, use the latest edition of *The National Fuel Gas Code ANSI Z223.1/NFPA 54\**.

Note: Where listed vented decorative logs are required, thermostat operation is not permitted.

# CAUTION: Do not remove the data plates attached to the heater base assembly. The data plates contain important warranty and safety information.

 With utility knife, cut the carton all the way around above the staples on the bottom tray. Lift the carton off the heater. Remove packing.

Note: The hood is located in the packing on the right hand side of the heater front. Lift the heater off the bottom tray.

#### OPERATION

This vent-free fireplace is clean burning. It requires no outside venting. There is no heat loss out a vent or up a chimney. Heat is generated by both realistic flames and glowing embers. When used without the optional blower, the fireplace requires no electricity making it ideal for emergency backup heat.

#### SAFETY DEVICE

This fireplace has a pilot with an Oxygen Depletion Sensing (ODS) safety shutoff system. The ODS/pilot is a required feature for vent-free room heaters. The ODS/pilot system shuts off the fireplace if there is not enough fresh air.

#### PIEZO IGNITION SYSTEM

This fireplace has a piezo ignitor. This system requires no matches, batteries, or other sources to light fireplace. State of Massachusetts: The installation must be made by a licensed plumber or gas fitter in the Commonwealth of Massachusetts.

Sellers of unvented propane or natural gas-fired supplemental room heaters shall provide to each purchaser a copy of 527 CMR 30 upon sale of the unit.

Vent-free gas products are prohibited for bedroom and bathroom installation in the Commonwealth of Massachusetts.

#### UNPACKING

- Locate two screws above top corners of the fireplace screen. Remove and discard these screws. Lift fireplace screen up and pull out to remove.
- 3. Remove protective packaging applied to logs, log base assembly, and fireplace.
- 4. Remove fireplace hood from carton insert.
- Check all items for any shipping damage. If damaged, promptly inform dealer where you bought fireplace.

#### OPTIONAL BLOWER ASSEMBLY ACCESSORY

This fireplace accepts an optional blower assembly (not included). The GA3650T Series blower operates thermostatically and features a variable speed control. The GA3750 Series operates manually and also features a variable speed control. The blower circulates heated air from the fireplace into the room. Use of blower is optional. See <u>Accessories</u>, page 33.

#### AIR FOR COMBUSTION AND VENTILATION

A WARNING: This heater shall not be installed in a room or space unless the required volume of indoor combustion air is provided by the method described in the National Fuel Gas Code, ANSI Z223.1/NFPA 54, the International Fuel Gas Code, or applicable local codes. Read the following instructions to insure proper fresh air for this and other fuel-burning appliances in your home.

Today's homes are built more energy efficient than ever. New materials, increased insulation, and new construction methods help reduce heat loss in homes. Home owners weather strip and caulk around windows and doors to keep the cold air out and the warm air in. During heating months, home owners want their homes as airtight as possible.

While it is good to make your home energy efficient, your home needs to breathe. Fresh air must enter your home. All fuel-burning appliances need fresh air for proper combustion and ventilation.

Exhaust fans, fireplaces, clothes dryers, and fuel burning appliances draw air from the house to operate. You must provide adequate fresh air for these appliances. This will insure proper venting of vented fuel-burning appliances.

#### PROVIDING ADEQUATE VENTILATION

The following are excerpts from National Fuel Gas Code, ANSI Z223.1/NFPA 54, Air for Combustion and Ventilation.

All spaces in homes fall into one of the three following ventilation classifications:

- 1. Unusually Tight Construction
- 2. Unconfined Space
- 3. Confined Space

The information on pages 5 through 7 will help you classify your space and provide adequate ventilation.

#### **Unusually Tight Construction**

The air that leaks around doors and windows may provide enough fresh air for combustion and ventilation. However, in buildings of unusually tight construction, you must provide additional fresh air. Unusually tight construction is defined as construction where:

- a. walls and ceilings exposed to the outside atmosphere have a continuous water vapor retarder with a rating of one perm (6 x 10<sup>-11</sup> kg per pa-sec-m<sup>2</sup>) or less with openings gasketed or sealed <u>and</u>
- b. weather stripping has been added on openable windows and doors <u>and</u>
- c. caulking or sealants are applied to areas such as joints around window and door frames, between sole plates and floors, between wall-ceiling joints, between wall panels, at penetrations for plumbing, electrical, and gas lines, and at other openings.

If your home meets all of the three criteria above, you must provide additional fresh air. See <u>Ventilation Air From Outdoors</u>, page 7. If your home does not meet all of the three criteria above, proceed to <u>Determining</u> <u>Fresh-Air Flow For Heater Location</u>.

#### **Confined and Unconfined Space**

The National Fuel Gas Code, ANSI Z223.1/ NFPA 54 defines a confined space as a space whose volume is less than 50 cubic feet per 1,000 Btu per hour (4.8 m<sup>3</sup> per kw) of the aggregate input rating of all appliances installed in that space and an unconfined space as a space whose volume is not less than 50 cubic feet per 1,000 Btu per hour (4.8 m<sup>3</sup> per kw) of the aggregate input rating of all appliances installed in that space. Rooms communicating directly with the space in which the appliances are installed\*, through openings not furnished with doors, are considered a part of the unconfined space.

\* Adjoining rooms are communicating only if there are doorless passageways or ventilation grills between them.

#### DETERMINING FRESH-AIR FLOW FOR FIREPLACE LOCATION

#### Determining if You Have a Confined or Unconfined Space

Use this work sheet to determine if you have a confined or unconfined space.

**Space:** Includes the room in which you will install fireplace plus any adjoining rooms with doorless passageways or ventilation grills between the rooms.

 Determine the volume of the space (length x width x height). Length x Width x Height = \_\_\_\_\_cu. ft. (volume of space)

#### AIR FOR COMBUSTION AND VENTILATION Continued

*Example:* Space size 20 ft. (length) x 16 ft. (width) x 8 ft. (ceiling height) = 2,560 cu. ft. (volume of space)

If additional ventilation to adjoining room is supplied with grills or openings, add the volume of these rooms to the total volume of the space.

 Multiply the space volume by 20 to determine the maximum Btu/Hr the space can support. (volume of space) x 20 = (Maxi-

The space can support with the space can support *Example:* 2,560 cu. ft. (volume of space) x 20 = 51,200 (maximum Btu/Hr the space can support)

3. Add the Btu/Hr of all fuel burning appliances in the space.

\* Do not include direct-vent gas appliances. Direct-vent draws combustion air from the outdoors and vents to the outdoors.

The space in the example is a confined space because the actual Btu/Hr used is more than the maximum Btu/Hr the space can support. You must provide additional fresh air. Your options are as follows:

- A. Rework worksheet, adding the space of an adjoining room. If the extra space provides an unconfined space, remove door to adjoining room or add ventilation grills between rooms. See <u>Ventilation Air From Inside Building</u>.
- B. Vent room directly to the outdoors. See <u>Ventilation Air From Outdoors</u> page 8.
- C. Install a lower Btu/Hr fireplace, if lower Btu/ Hr size makes room unconfined.

If the actual Btu/Hr used is less than the maximum Btu/Hr the space can support, the space is an unconfined space. You will need no additional fresh air ventilation.

A WARNING: If the area in which the heater may be operated does not meet the required volume for indoor combustion air, combustion and ventilation air shall be provided by one of the methods described in the National Fuel Gas Code, ANSIZ223.1/NFPA 54, the International Fuel Gas Code, or applicable local codes.

#### VENTILATION AIR

#### Ventilation Air From Inside Building




Figure 3 - Ventilation Air from Inside Building

This fresh air would come from an adjoining unconfined space. When ventilating to an adjoining unconfined space, you must provide two permanent openings: one within 12" of the ceiling and one within 12" of the floor on the wall connecting the two spaces (see options 1 and 2, Figure 3). You can also remove door into adjoining room (see option 3, Figure 3). Follow the *National Fuel Gas Code, ANSI Z223.1/NFPA 54, Air for Combustion and Ventilation* for required size of ventilation grills or ducts.

#### AIR FOR COMBUSTION AND VENTILATION

Continued

#### Ventilation Air From Outdoors

Provide extra fresh air by using ventilation grills or ducts. You must provide two permanent openings: one within 12" of the ceiling and one within 12" of the floor. Connect these items directly to the outdoors or spaces open to the outdoors. These spaces include attics and crawl spaces. Follow the National Fuel Gas Code, ANSI Z223.1/NFPA 54, Air for Combustion and Ventilation for required size of ventilation grills or ducts.

*IMPORTANT:* Do not provide openings for inlet or outlet air into attic if attic has a thermostat-controlled power vent. Heated air entering the attic will activate the power vent.

NOTICE: This heater is intended for use as supplemental heat. Use this heater along with your primary heating system. Do not install this heater as your primary heat source. If you have a central heating system, you may run system's circulating blower while using heater. This will help circulate the heat throughout the house. In the event of a power outage, you can use this heater as your primary heat source.

WARNING: A qualified service person must install fireplace. Follow all local codes.

WARNING: Never install the fireplace

- in a bedroom or bathroom
- in a recreational vehicle
- where curtains, furniture, clothing, or other flammable objects are less than 36" from the front and 42" from the top of fireplace. For side clearances see Figure 8, page 10
- in high traffic areas
- · in windy or drafty areas




Figure 4 - Ventilation Air from Outdoors

#### INSTALLATION

A CAUTION: This fireplace creates warm air currents. These currents move heat to wall surfaces next to fireplace. Installing fireplace next to vinyl or cloth wall coverings or operating heater where impurities (such as, but not limited, to tobacco smoke, aromatic candles, cleaning fluids, oil or kerosene lamps, etc.) in the air exist, may discolor walls or cause odors.

Note: Your fireplace is designed to be used in zero clearance installations. Wall or framing material can be placed directly against any exterior surface on the rear, sides, or top of your fireplace, except where standoff spacers are integrally attached. If standoff spacers are attached to your fireplace, these spacers can be placed directly against wall or framing materials.

Use the dimensions shown for rough openings to create the easiest installation. See <u>Built-In</u> <u>Fireplace Installation</u>, page 11.

*IMPORTANT:* Vent-free heaters add moisture to the air. Although this is beneficial, installing fireplace in rooms without enough ventilation air may cause mildew to form from too much moisture. See <u>Air for Combustion and Ventilation</u>, page 6.

*IMPORTANT:* Make sure the fireplace is level. If fireplace is not level, log set will not work properly.

#### CHECK GAS TYPE

Use the correct gas type (natural or propane/ LP) for your fireplace. If your gas supply is not correct, do not install fireplace. Call dealer where you bought fireplace for proper type fireplace.

WARNING: This appliance is equipped for natural or propane/ LP gas but not both. Gas type is indicated on rating plate. Field conversion is not permitted.

#### ELECTRICAL HOOKUP

#### (Models GA3750A and GA3650TB Blower Accessories, and GA3555 Internal Duplex Kit)

This fireplace accepts a blower assembly with an electrical cord. The electrical cord is five feet in length. You must locate fireplace within reach of a 120 volt grounded electrical outlet. If not, you must install an electrical outlet within reach of fireplace power cord. The GA3555 outlet accessory may be used for built-in applications with blower accessory installed.

#### INSTALLING HOOD




Figure 5 - Installing Hood

Install hood to rail already installed in fireplace as shown in Figure 5. Use 3 Phillips screws provided.

#### ASSEMBLING AND ATTACHING OPTIONAL PERIMETER TRIM (Included with Mantel Accessory)

*IMPORTANT:* If you are recessing the firebox in a wall, do not attach trim at this time. See *Built-In Fireplace Installation*, page 11.

Note: These instructions show assembling and attaching trim to fireplace.

- 1. Remove packaging from three pieces of trim.
- Locate four screws, two adjusting plates with set screws, and two shims in the hardware packet.




Figure 6 - Assembling Perimeter Trim

- 3. Align shim under adjusting plate as shown in Figure 6.
- 4. Slide one end of adjusting plate/shim in slot on mitered edge of top trim (see Figure 6).
- Slide other end of adjusting plate/shim in slot on mitered edge of side trim (see Figure 6).
- While firmly holding edges of trim together, tighten both set screws on the adjusting plate with slotted screwdriver.
- 7. Repeat steps 1 through 6 for other side.




Figure 7 - Attaching Perimeter Trim to Fireplace

- Tighten trim hanging screws (#10 x 6.25 shoulder) into holes in cabinets. Place the assembled trim onto fireplace cabinet. Align hanging notches on trim with hanging screws on side of fireplace (see Figure 7). Push trim firmly into place, sliding hanging notches over hanging screws.

#### INSTALLATION CLEARANCES


WARNING: Maintain the minimum clearances. If you can, provide greater clearances from floor, ceiling, and adjoining wall.

Carefully follow the instructions below. This will ensure safe installation.


#### Minimum Clearances For Side Combustible Material, Side Wall, and Ceiling

- A. Clearances from the side of the fireplace cabinet to any combustible material and wall should follow diagram in Figure 8. *Example:* The face of a mantel, bookshelf, etc. is made of combustible material and protrudes 3 <sup>1</sup>/<sub>2</sub>" from the wall. This combustible material must be 4" from the side of the fireplace opening (see Figure 8).
- B. Clearances from top of fireplace opening to ceiling should not be less than 42".

MINIMUM CLEARANCE TO COMBUSTIBLE MATERIALS Top 0", Left and Right Sides 16", Bottom and Rear 0", Front 36"



\*Minimum 16" from Side Wall



#### CONVENTIONAL FIREPLACE INSTALLATION

Conventional installation of this fireplace involves installing fireplace along with the corner, face, or cabinet mantel with hearth base accessories against a wall in your home. Follow the instructions in this section to install the fireplace in this manner.

 Assemble cabinet mantel, hearth base, and trim accessories. Assembly instructions are included with each accessory.




Figure 9 - Placing Hearth Base Accessory Against Wall

- When installing blower, install a properly grounded, 120 volt three-prong electrical outlet at fireplace location if an outlet is not there. If possible, locate outlet so cabinet mantel will cover it when installed (see Figure 9).
- Install gas piping to fireplace location. This installation includes an approved flexible gas line (if allowed by local codes) after the equipment shutoff valve. The flexible gas line must be the last item installed on the gas piping. See <u>Installing Gas Piping</u> to Fireplace Location, page 13.
- 4. Place hearth base accessory against wall at installation location. Cut an access hole in hearth top to run flexible gas line to fireplace (see Figure 9). Make sure to locate access hole so cabinet mantel will cover it when installed.

Note: You can secure base to floor using wood screws. Countersink screw heads and putty over.

- 5. Route flexible gas line through access hole in hearth base.




Figure 10 - Installing Cabinet Mantel

- Center cabinet mantel on hearth base (see Figure 10, page 11). Make sure mantel is flush against wall.




Figure 11 - Location of Nailing Flanges

- 7. Break off nailing flanges (see Figure 11, page 11) with hammer or pliers.
- 8. Place cardboard or other protective material on top of hearth base. Carefully set fireplace on protective material, with back of fireplace inside mantel opening.
- Attach flexible gas line from fireplace gas regulator to gas supply. See <u>Connecting</u> <u>Fireplace to Gas Supply</u>, page 14.

10. If blower is installed, route blower electrical cord through access holes in either side of fireplace.

Note: Bushing may be moved if necessary. Plug electrical cord into electrical outlet.

 Carefully insert fireplace into cabinet mantel. Be careful not to scratch or damage hearth base, cabinet mantel, or any laminate trim on hearth base. Remove protective material from top of hearth base and from front of fireplace (if any).

Note: You can secure fireplace to hearth or floor. Open lower louver. Locate screw holes in bottom of base. Tighten wood screws through these holes and into hearth or floor.

12. Check all gas connections for leaks. See <u>Checking Gas Connections</u>, page 15.




Figure 12 - Inserting Fireplace Into Cabinet Mantel

## BUILT-IN FIREPLACE

Built-in installation of this fireplace involves installing fireplace into a framed-in enclosure. This makes the front of fireplace flush with wall. If installing a mantel above the fireplace, you must follow the clearances shown in Figure 16, page 12. Follow the instructions below to install the fireplace in this manner.




Figure 13 - Rough Opening for Installing in Wall






Figure 14 - Rough Opening for Installing in Corner

 Frame in rough opening. Use dimensions shown in Figure 13 for the rough opening. If installing in a corner, use dimensions shown in Figure 14, Figure 12, for the rough opening. The height is 33" which is the same as the wall opening above.

- If using blower, install and properly ground GA3555, three-prong 120 volt electrical outlet, in fireplace. Follow instructions included in kit.
- Install gas piping into fireplace location. This installation includes an approved flexible gas line (if allowed by local codes) after the equipment shutoff valve. The flexible gas line must be the last item installed on the gas piping. See <u>Installing Gas Piping</u> <u>to Fireplace Location</u>, page 13.
- Carefully set fireplace in front of rough opening with back of fireplace inside wall opening.
- Carefully insert fireplace into rough opening.
- Attach flexible gas line to gas supply. See <u>Connecting Fireplace to Gas Supply</u>, page 14.
- Attach fireplace to wall studs using nails or wood screws through holes in nailing flange (see Figure 15).
- Check all gas connections for leaks. See <u>Checking Gas Connections</u>, page 15.

- 9. Plug electrical cord into electrical outlet installed in step 2.
- 10. Install trim after final finishing and/or painting of wall (see Figure 7, page 9).

*IMPORTANT:* When finishing your firebox, combustible materials such as wall board, gypsum board, sheet rock, drywall, plywood, etc. may be butted up next to the sides and top of the firebox. Combustible materials should never overlap the firebox front facing.

## WARNING: Do not allow any combustible materials to overlap the firebox front facing.

*IMPORTANT*: Noncombustible materials such as brick, tile, etc. may overlap the front facing, but should never cover any necessary openings like louvered slots.

WARNING: Do not allow noncombustible materials to cover any necessary openings like louvered slots.

WARNING: Use only noncombustible mortar or adhesives when overlapping the front facing with noncombustible facing material.




Figure 16 - Minimum Mantel Clearances for Built-In Installation

#### Mantel Clearances for Built-In Installation

If placing mantel above built-in fireplace, you must meet minimum clearance between mantel shelf and top of fireplace opening.

NOTICE: If your installation does not meet the minimum clearances shown, you must do one of the following:

- raise the mantel to an acceptable height
- remove the mantel

NOTICE: Surface temperatures of adjacent walls and mantels become hot during operation. Walls and mantels above the firebox may become hot to the touch. If installed properly, these temperatures meet the requirement of the national product standard. Follow all minimum clearances shown in this manual.

#### INSTALLING GAS PIPING TO FIREPLACE LOCATION

WARNING: This appliance requires a 1/2" NPT (National Pipe Thread) inlet connection to the pressure regulator.

WARNING: A qualified service person must connect fireplace to gas supply. Follow all local codes.

**CAUTION:** Never connect propane/LP fireplace directly to the propane/LP supply. This fireplace requires an external regulator (not supplied). Install the external regulator between the fireplace and propane/LP supply. WARNING: Never connect natural gas fireplace to private (non-utility) gas wells. This gas is commonly known as wellhead gas.

#### Installation Items Needed

Before installing fireplace, make sure you have the items listed below.

- external regulator for propane/LP unit only (supplied by installer)
- piping (check local codes)
- sealant (resistant to propane/LP gas)
- equipment shutoff valve \*
- test gauge connection \*
- sediment trap (optional)
- · tee joint
- pipe wrench
- approved flexible gas line with gas connector (if allowed by local codes) (not provided)

\* A equipment shutoff valve with 1/8" NPT tap is an acceptable alternative to test gauge connection. Purchase the optional equipment shutoff valve from your dealer.




Figure 17 - External Regulator on Propane/LP Supply Tank with Vent Pointing Down

For propane/LP units, the installer must supply an external regulator. The external regulator will reduce incoming gas pressure. You must reduce incoming gas pressure to between 11" and 14" of water. If you do not reduce incoming gas pressure, heater regulator damage could occur. Install external regulator with the vent pointing down as shown in Figure 17, page 14. Pointing the vent down protects it from freezing rain or sleet.

CAUTION: Use only new, black iron or steel pipe. Internally-tinned copper tubing may be used in certain areas. Check your local codes. Use pipe of 1/2" diameter or greater to allow proper gas volume to fireplace. If pipe is too small, undue loss of volume will occur.




Figure 18 - Gas Connection

Installation must include an equipment shutoff valve, union, and plugged 1/8" NPT tap. Locate NPT tap within reach for test gauge hook up. NPT tap must be upstream from fireplace (see Figure 18).

*IMPORTANT*: Install equipment shutoff valve in an accessible location. The equipment shutoff valve is for turning on or shutting off the gas to the appliance.

Check your building codes for any special requirements for locating equipment shutoff valve to fireplaces.

Apply pipe joint sealant lightly to male NPT threads. This will prevent excess sealant from going into pipe. Excess sealant in pipe could result in clogged fireplace valves. Never use sealant on flare threads.

## WARNING: Use pipe joint sealant that is resistant to liquid petroleum (LP) gas.

We recommend that you install a sediment trap in supply line as shown in Figure 18. Locate sediment trap where it is within reach for cleaning. Install in piping system between fuel supply and fireplace. Locate sediment trap where trapped matter is not likely to freeze. A sediment trap traps moisture and contaminants. This keeps them from going into fireplace gas controls. If sediment trap is not installed or is installed wrong, fireplace may not run properly.

## CONNECTING FIREPLACE TO GAS SUPPLY

#### Installation Items Needed

- 5/16" hex socket wrench or nut-driver
- · Phillips screwdriver
- sealant (resistant to propane/LP gas, not provided)
- Remove fireplace screen. Remove two screws that hold fireplace screen in place for shipping. These screws are located near top of screen. Discard screws. Lift fireplace screen up and pull out to remove.




Figure 19 - Removing Log Base Assembly From Fireplace

- Remove screws that attach log base assembly to fireplace (see Figure 19, page 15). Carefully lift up log base assembly and remove from fireplace (see Figure 19, page 15).

Note: If adding the HFL series brick liner accessory, install it now. Follow instructions in HFL accessory kit.

 Route gas line (provided by installer) from equipment shutoff valve to fireplace. Route flexible gas supply line through one of the access holes.

### INSTALLATION

Continued




Figure 20 - Attaching Flexible Gas Lines Together NOTICE: Most building codes do not permit concealed gas connections. A flexible gas line is provided to allow accessibility from the fireplace (see Figure 20). The flexible gas supply line connection to the equipment shutoff valve should be accessible.

- Attach the flexible gas line to gas supply (see Figure 20). Check tightness of flexible gas line attached to gas regulator of fireplace (see Figure 20).
- 5. Check all gas connections for leaks. See <u>Checking Gas Connections</u>.
- Replace log base assembly back into fireplace. Feed flexible gas line into fireplace base area while replacing log base assembly. Make sure the entire flexible gas line is in fireplace base area. Reattach log base assembly to fireplace with screws removed in step 2, page 14.

CAUTION: Do not pick up log base assembly by burner. This could damage burner. Only handle base by grates.

CHECKING GAS CONNECTIONS

WARNING: Test all gas piping and connections, internal and external to unit, for leaks after installing or servicing. Correct all leaks at once.

WARNING: Never use an open flame to check for a leak. Apply a noncorrosive leak detection fluid to all joints. Bubbles forming show a leak. Correct all leaks at once.

**CAUTION:** Make sure external regulator has been installed between propane/LP supply and fireplace. See guidelines under <u>Connecting Fireplace to Gas</u> <u>Supply</u>, page 14.

#### PRESSURE TESTING GAS SUPPLY PIPING SYSTEM

### Test Pressures In Excess Of 1/2 PSIG (3.5 kPa)

- Disconnect fireplace with its main gas valve (control valve) and equipment shutoff valve from gas supply piping system. Pressures in excess of 1/2 psig will damage fireplace regulator.
- 2. Cap off open end of gas pipe where equipment shutoff valve was connected.
- Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas or opening main gas valve located on or near gas meter for natural gas, or using compressed air.

- Check all joints of gas supply piping system. Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak.
- 5. Correct all leaks at once.
- 6. Reconnect fireplace and equipment shutoff valve to gas supply. Check reconnected fittings for leaks.

### Test Pressures Equal To or Less Than 1/2 PSIG (3.5 kPa)




Figure 21 - Equipment Shutoff Valve

- 1. Close equipment shutoff valve (see Figure 21).
- Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas or opening main gas valve located on or near gas meter for natural gas, or using compressed air.






Figure 22 - Checking Gas Joints for Natural Gas

- Check all joints from gas meter to equipment shutoff valve for natural gas or propane/LP supply to equipment shutoff valve for propane/LP (see Figures 22 and 23). Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak.
- 4. Correct all leaks at once.

## PRESSURE TESTING FIREPLACE GAS CONNECTIONS

- Open equipment shutoff valve (see Figure 21).
- Open main gas valve located on or near gas meter for natural gas or open propane/LP supply tank valve.
- 3. Make sure control knob of fireplace is in the OFF position.
- Check all joints from equipment shutoff valve to gas control valve (see Figures 22 or 23). Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak.
- 5. Correct all leaks at once.
- Light fireplace (see <u>Operation</u>, page 18). Check all other internal joints for leaks.
- 7. Turn off fireplace (see <u>To Turn Off Gas to</u> <u>Appliance</u>, page 19).

#### INSTALLING LOGS

WARNING: Failure to position the parts in accordance with these diagrams or failure to use only parts specifically approved with this heater may result in property damage or personal injury.

**CAUTION:** Do not remove the data plates attached to the heater base assembly. The data plates contain important safety and warranty information.

It is very important to install these logs exactly as instructed. Do not modify logs. Only use logs supplied with heater.




Figure 24 - Installing Bottom Logs

- 1. Place bottom log in center of the base assembly as shown in Figure 24.
- Rest rear log in back corner sections of base assembly as shown in Figure 24. Make sure log is completely vertical and not leaning in toward burner where the flame will touch the log.
- 3. Position front right log against right side of grate prongs (see Figure 24).
- Position front left log against left side of grate prongs (see Figure 24).




Figure 25 - Installing Top Logs

- Place middle right log over front right and bottom logs as shown in Figure 25. Be sure hole in middle right log seats over pin in bottom log.
- Place middle left log over front left and bottom logs as show in Figure 25. Be sure hole in middle left log seats over pin in front left log.




Figure 26 - Installing Fireplace Screen

- Install fireplace screen by slipping notches of fireplace screen over screws on front of fireplace (see Figure 26).

WARNING: You must operate this fireplace with the fireplace screen in place. Make sure fireplace screen is in place before running fireplace.

#### **OPERATION**



WARNING: If you do not follow these instructions exactly, a fire or explosion may result causing property damage, personal injury or loss of life.

- A. This appliance has a pilot which must be lighted by hand. When lighting the pilot, follow these instructions exactly.
- B. BEFORE LIGHTING smell all around the appliance area for gas. Be sure to smell next to the floor because some gas is heavier than air and will settle on the floor.

WHAT TO DO IF YOU SMELL GAS

- Do not try to light any appliance.
- Do not touch any electric switch; do not use any phone in your building.
- Immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions.
- If you cannot reach your gas supplier, call the fire department.
- C. Use only your hand to push in or turn the gas control knob. Never use tools. If the knob will not push in or turn by hand, don't try to repair it, call a qualified service technician or gas supplier. Force or attempted repair may result in a fire or explosion.
- D. Do not use this appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.

#### LIGHTING INSTRUCTIONS

WARNING: You must operate this fireplace with the fireplace screen in place. Make sure fireplace screen is installed before running fireplace. NOTICE: During initial operation of new fireplace, burning logs will give off a paper-burning smell. Open damper or window to vent smell. This will only last a few hours.

- 1. STOP! Read the safety information in column 1.
- 2. Make sure equipment shutoff valve is fully open.
- 3. Set selector switch in OFF position.

WARNING: Burners will come on automatically within one minute when the selector switch is in the ON position after the pilot is lit.

- 4. Press in and turn control knob clockwise to the OFF position.
- Wait five (5) minutes to clear out any gas. Then smell for gas, including near the floor. If you smell gas, STOP! Follow "B" in the safety information, column 1. If you don't smell gas, go to the next step.

Note: You may be running this heater for the first time after hooking up to gas supply. If so, the control knob may need to be pressed in for 30 seconds or more. This will allow air to bleed from the gas system.

## CAUTION: Do not try to adjust heating levels by using the equipment shutoff valve.

 With control knob pressed in, press and release ignitor button. This will light pilot. The pilot is attached to the front burner. If needed, keep pressing ignitor button until pilot lights.

Note: If pilot does not stay lit, contact a qualified service person or gas supplier for repairs. Until repairs are made, light pilot with match. To light pilot with match, see <u>Manual Lighting Procedure</u>, page 19.

OPERATION Continued


 Keep control knob pressed in for 30 seconds after lighting pilot. After 30 seconds, release control knob.

• If control knob does not pop out when released, contact a qualified service person or gas supplier for repairs.

Note: If pilot goes out, repeat steps 4 through 8 beginning on page 18.

- Slightly push in and turn control knob counterclockwise to the ON position.
- 10. Wait one minute and switch selector switch to the ON position to light burners.
- 11. Set flame adjustment knob to any level between HI and LO.
- 12. To leave pilot lit and shut off burners only: turn control knob clockwise to the PILOT position, or use remote control manual OFF button, or set selector switch in the OFF position.

WARNING: Make sure the selector switch is in the OFF position when you are away from home for long periods of time. Heater will come on automatically with selector switch in the ON position.




Figure 28 - Pilot (Natural)




Figure 29 - Pilot (Propane/LP)

TO TURN OFF GAS TO APPLIANCE

- 1. Turn control knob clockwise to the OFF position.
- 2a. Set selector switch in the OFF position.
- 2b. If Using Optional Hand-Held Remote: Set selector switch in the OFF position to keep from draining battery.
- 3. Close equipment shutoff valve (see Figure 21, page 16).

#### MANUAL LIGHTING PROCEDURE

- 1. Follow steps 1 through 6 under *Lighting Instructions*, page 18.
- 2. Press control knob and light pilot with match.
- Keep control knob pressed in for 30 seconds after lighting pilot. After 30 seconds, release control knob. Now follow steps 9 through 11, column 1.

#### OPTIONAL HAND-HELD REMOTE OPERATION

Note: All remote control accessories must be purchased separately (see <u>Accessories</u>, page 33). Follow instructions included with the remote control.


NOTICE: You must light the pilot before using the hand-held remote control unit. See <u>Lighting</u> <u>Instructions</u>, page 18.


#### Figure 30 - Setting the Selector Switch, Control Knob, and Flame Adjustment Knob for Hand-Held Remote Operation

After lighting, let pilot flame burn for about one minute. Turn control knob to ON position. Adjust flame adjustment knob anywhere between HI and LO. Slide the selector switch to the REMOTE position (see Figure 30, page 20).

Note: The burner may light if hand-held remote was on when selector switch was last turned off. You can now turn the burner on and off with the hand-held remote control unit.

#### OPERATION Continued

*IMPORTANT*: Do not leave the selector switch in the REMOTE or ON position when the pilot is not lit. This will drain the battery.



Selector Switch in Remote Position (Optional Hand-Held Remote Control)

#### **ON/OFF MODEL HRC100**

Hold the control button on the hand-held remote until burner turns on. Hold the control button again until burner turns off (see Figure 31).

TO LOCK press both buttons on hand-held remote control until light stops flashing. Handheld remote control is now locked. If the fire is on it will be turned off automatically. In the locked state, the light will not light up when any button is pressed.

TO UNLOCK press both buttons together on hand-held remote control until the light stops flashing. The hand-held remote is now unlocked.

#### THERMOSTAT MODEL HRC200




Figure 32 - Thermostat Hand-Held Remote Control Unit Selections HRC200

The hand-held remote can be operated using either the manual mode (MANU) or thermostatic mode (AUTO) (see Figure 32). To select Fahrenheit/Centigrade mode display, carefully press the  $^{\circ}C/^{\circ}F$  mode button with the end of a paper clip or similar blunt object.

#### Manual Mode

- 1. Press the POWER and LOCK buttons together to turn on the hand-held remote control.
- 2. Press the MANU button to turn on the fireplace.
- 3. Press the POWER and LOCK buttons together to turn off the fireplace.

#### Auto (Thermostatic) Mode

- 1. Press the POWER and LOCK buttons together to turn on the hand-held remote control.
- 2. Press AUTO button to select this mode.
- 3. Set the desired room temperature by pressing the TEMP + or buttons.
- 4. Press the POWER and LOCK buttons together to turn off the fireplace

Note: Do not leave the hand-held remote in the AUTO mode close to the fireplace. The radiant heat from the fireplace will turn off the fireplace. Ideally, place the hand-held remote in the center of the room facing towards the fireplace.

#### **OPERATION**

Continued

Note: Do not hold the hand-held remote for a long time. Body temperature will affect its operation in the AUTO mode.

#### Safety Features

When away from home for an extended period of time or as a child safety feature to prevent accidental ignition of the fireplace, the receiver ON/OFF/REMOTE switch should be in the OFF position.

#### Auto Shutoff Feature

- If the average room temperature reaches a range of 82° F (28° C) to 92° F (33° C), the hand-held remote control will perform a safety override and shut the fireplace off. This feature is not available in the MANU mode.
- The receiver continuously receives signals from the hand-held remote to control the room temperature. If the hand-held remote is misplaced, obstructed, or for any reason cannot transmit to the receiver, the receiver will shut off the fireplace. This will occur in 8 or more minutes depending upon location of remote transmitter and strength of batteries.

#### Key Pad Lock Feature

This feature allows the user to lock/unlock the keypad on the hand-held remote in the MANU or AUTO mode to prevent inadvertent operation (i.e. children operating the hand-held remote control, etc.). The keypad is locked in either on or off. Press the POWER and LOCK buttons together to turn the unit on or off.

#### OPTIONAL BLOWER OPERATION

WARNING: This fireplace has a three-prong, grounded electrical plug. This plug helps protect you against electrical shock. Only connect plug to a properly grounded, three-prong receptacle. Do not cut or remove the grounding prong from this plug.

Locate the blower switch by opening lower louver on fireplace. Blower switch is located at lower left inside louver door.

The GA3650TB thermostat-controlled blower has a variable speed control with an ON/ OFF switch. The blower will start when the thermostat senses a sufficient increase in firebox temperature. The GA3750A variable speed blower also has an ON/OFF switch built into the variable speed control.

**Note for GA3650TB Only:** If you are using GA3650TB blower, your fireplace and blower will not turn on and off at the same time. The fireplace may run for several minutes before the blower turns on. After the heater modulates to the pilot position, the blower will continue to run. The blower will shut off after the firebox temperature decreases.

Note: It is safe to operate fireplace with blower turned off. However, the blower helps distribute heated air from the fireplace.

Follow installation instructions included with the blower accessory.

#### **INSPECTING BURNERS**

Check pilot flame pattern and burner flame patterns often.

#### PILOT FLAME PATTERN

Figure 32 shows a correct pilot flame pattern. Figure 33 shows an incorrect pilot flame pattern. The incorrect pilot flame is not properly heating the thermocouple. When the thermocouple cools, the heater will shut down.

If pilot flame pattern is incorrect, as shown in Figure 33

- turn heater off (see <u>To Turn Off Gas to Appliance</u>, page 19)
- see <u>Troubleshooting</u>, page 24

Note: The pilot flame on natural gas units will have a slight curve, but flame should be blue and have no yellow or orange color.

#### INSPECTING BURNERS Continued

#### MAIN BURNER

Periodically inspect all burner flame holes with the heater running. All slotted burner flame holes should be open with yellow flame present. All round burner flame holes should be open with a small blue flame present. Some burner flame holes may become blocked by debris or rust, with no flame present. If so, turn off heater and let cool. Remove blockage. Blocked burner flame holes may create soot.

#### FRONT BURNER FLAME PATTERN

WARNING: If front burner flame pattern shows yellow tipping, your fireplace could produce increased levels of carbon monoxide. Follow instructions below. Yellow flame on rear burner is normal.




Figure 35 - Correct Burner Flame Pattern Yellow Tipping At Top of Blue Flame




Figure 36 - Incorrect Burner Flame Pattern

NOTICE: Do not mistake orange flames with yellow tipping. Dirt or other fine particles are burned by fireplace, causing brief patches of orange flame. Figure 35 shows correct front burner flame pattern. Figure 36 shows incorrect front burner flame pattern. The incorrect burner flame pattern shows yellow tipping at top of blue flame.

If front burner flame pattern is incorrect, as shown in Figure 36

- turn fireplace off (see <u>To Turn Off Gas to</u> <u>Appliance</u>, page 19)
- see <u>Troubleshooting</u>, page 24

#### **CLEANING AND MAINTENANCE**

WARNING: Turn off fireplace and let cool before cleaning.

**CAUTION:** You must keep control areas, burner, and circulating air passageways of fireplace clean. Inspect these areas of fireplace before each use. Have fireplace inspected yearly by a qualified service person. Fireplace may need more frequent cleaning due to excessive lint from carpeting, bedding material, pet hair, etc.

WARNING: Failure to keep the primary air opening(s) of the burner(s) clean may result in sooting and property damage.

## BURNER INJECTOR HOLDER AND PILOT AIR INLET HOLE

The primary air inlet holes allow the proper amount of air to mix with the gas. This provides a clean burning flame. Keep these holes clear of dust, dirt, lint, and pet hair. Clean these air inlet holes prior to each heating season. Blocked air holes will create soot. We recommend that you clean the unit every three months during operation and have heater inspected yearly by a qualified service person.

We also recommend that you keep the burner tube and pilot assembly clean and free of dust and dirt. To clean these parts we recommend using compressed air no greater than 30 PSI.

#### CLEANING AND MAINTENANCE Continued

Your local computer store, hardware store, or home center may carry compressed air in a can. If using compressed air in a can, please follow the directions on the can. If you don't follow directions on the can, you could damage the pilot assembly.

- 1. Shut off unit, including pilot. Allow unit to cool for at least thirty minutes.




Figure 37 - Injector Holder On Outlet **Burner Tube**

- 2. Inspect burner, pilot, and primary air inlet holes on injector holder for dust and dirt (see Figure 37).
- 3. Blow air through the ports/slots and holes in the burner
- 4. Check the injector holder located at the end of the burner tube again. Remove any large particles of dust, dirt, lint, or pet hair with a soft cloth or vacuum cleaner nozzle.
- 5. Blow air into the primary air holes on the injector holder.
- 6. In case any large clumps of dust have now been pushed into the burner repeat steps 3 and 4

must be connected exactly as shown.




Figure 38 - Pilot Inlet Air Hole

Clean pilot assembly also. A yellow tip on the pilot flame indicates dust and dirt in the pilot assembly. There is a small pilot air inlet hole about 2" from where the pilot flame comes out of the pilot assembly (see Figure 38). With unit off. lightly blow air through the air inlet hole. You may blow through a drinking straw if compressed air is not available.






